## **Strategic objective 2**

Strategy will enhance child well-being through achieving an Increase in children who are well nourished (ages 0-5).

**The Objective above seek to bridge critical gaps identified in R&L below**

29% of children under 5 years are stunted as per the baseline report

21.4% poverty rate.

- ❖ Saving for transformation (S4T)- Credit access-No Poverty
- ❖ Local value chain development (LVCD)-Market led production-household income
- ❖ Climate Smart Agriculture (CSA)- Sustainable Agriculture Production-Climate Action
- ❖ Community Based Disaster Risk Management (BDRM)-Disaster mgt
- ❖ Natural Resource Management (NRM)-Sustainable Natural resource mgt for Agriculture Production
- ❖ Microfinance (MF)-Sustainable credit access by households-No poverty

# Saving for Transformation (S4T) intervention- No poverty (SDG one)

---

## What is Saving for Transformation?

- ❖ This is a methodology of saving and borrowing among self selected participants/households.
- ❖ S4T group is a self selected and governed groups of people usually 15-30 members who decide to save together and take small loans that attract small interest on a monthly basis.
- ❖ The activities of S4T groups run for a minimum of 8 and maximum of 12 months there after these money is shared out among members
- ❖ S4T Is a sustainable platform for families to save and access small loans.

# WHY SAVING FOR TRANSFORMATION?

---

- ❖ S4T builds resilience by enabling community members to develop skills and access to funds to cope with household emergencies, learn long-term coping strategies, with focus on health, nutrition and education of their children and invest in their own livelihoods.
- ❖ Processes involved in the bank setting ie loan application, collateral, account opening e.t.c.
- ❖ Most participants do not know how to read and write which makes it more complex in the bank setting.
- ❖ The distance of most financial institutions from the beneficiaries.



# Saving for transformation products

- ❖ Membership fees (For administration and members commitment)
- ❖ Savings/Shares/tokens
- ❖ Loans (Principle + interest)
- ❖ Welfare/social fund/Emergency
- ❖ Fines

**Note;** As NO last year farmers were able to save up to a tune of **89,817,655,000/=** MIS national data base. **SDG –NO POVERTY**
